ITEM #1 PUBLIC HEARING -- VESTING TENTATIVE TRACT MAP (VTTM) 19108 WITHIN RMV PLANNING AREA 2, SUBAREA 2.3, IN UNINCORPORATED SOUTH ORANGE COUNTY.

LOCATION: The project site is located on Lots 24-33 of Tract 17605 within Subarea 2.3 of the Ranch Plan Planned Community, in the Fifth (5th) Supervisorial District

APPLICANT: The New Home Company

ENGINEER: Hunsaker & Associates

Staff requests that the Subdivision Committee review and approve "B" Vesting Tentative Tract Map 19108 (VTTM 19108) to subdivide a 1.21-acre site within the unincorporated Ranch Plan Planned Community area into 9 legal lots: 7 numbered lots for conventional single-family detached dwellings, 1 numbered lot for a neighborhood pocket park, and 1 lettered lot for a landscaped area.

RECOMMENDED ACTION(S):

1. Receive staff report and public testimony as appropriate;
2. Find that Final EIR 589, previously certified on November 8, 2004; Addendum 1.0 (PA060023) approved July 2006, Addendum 1.1 (PA110003-06) approved February 24, 2011, and the Planning Area 2 Addendum (PA130001-06) approved March 27, 2013, reflect the independent judgment of the County and are adequate to satisfy the requirements of CEQA for approval of Vesting Tentative Tract Map (VTTM) 19108, which is a necessarily included element contemplated as part of the whole of the action considered in Final EIR 589, Addendum 1.0, Addendum 1.1, and the Planning Area 2 Addendum.
 - a. The circumstances of the project are substantially the same as described in Final EIR 589, Addendum 1.0, Addendum 1.1, and the Planning Area 2 Addendum which adequately addressed the effects of the project proposed in VTTM19108. No substantial changes have been made in the project that involve new significant environmental effects or a substantial increase in the severity of previously identified significant effects; no substantial changes have occurred in the circumstances under which the project is being undertaken, that involve new significant environmental effects or a substantial increase in the severity of previously identified environmental effects; and no new information of substantial importance to the project which was not known or could not have been known when Final EIR 589, Addendum 1.0, Addendum 1.1, and the Planning Area 2 Addendum were certified and approved has become known; therefore, no further environmental review is required.
 - b. Final EIR 589, Addendum 1.0, Addendum 1.1, and the Planning Area 2 Addendum are adequate to satisfy the requirements of CEQA for VTTM19108.
 - c. All mitigation measures are fully enforceable pursuant to Public Resources Code section 21081.6(b) and have either been adopted as conditions, incorporated as part of the project design, or included in the procedures of project implementation.
3. Approve VTTM19108, subject to the attached Findings and Conditions of Approval.

III. PUBLIC COMMENTS:

At this time, members of the public may address the Subdivision Committee regarding any off-agenda items within the subject matter jurisdiction of the Committee provided that no action may be taken on off-agenda items unless authorized by law. Comments shall be limited to three minutes per person and twenty minutes for all comments, unless different time limits are set by the Chairperson subject to the approval of the Committee.
