To speak on a matter not appearing in the agenda, but under the jurisdiction of the Planning Commission, you may do so during Public Comments at the end of the meeting. When addressing the Planning Commission, it is requested that you state your name for the record. Address the Planning Commission as a whole through the Chair. Comments to individual Commissioners or staff are not permitted. Speakers are limited to three (3) minutes per item with twenty (20) minutes cumulative for the entire meeting. Power Point and video presentations must be requested in advance of the meeting through the Secretary.

Staff is requesting the Planning Commission approve PA20-0255 and certify the applicants listed therein to be placed on the County’s “Certified Acoustical Consultants” list for a period of five (5) years.

Recommended Action(s):

2. Find that the proposed Certification of Acoustical Consultants is not a ‘project’ per CEQA Guidelines Section 15378 and Public Resources Code 21065;
3. Find that the subject applicants meet the minimum qualifications as specified in the County’s ‘Land Use/Noise Compatibility Manual’ adopted by the Board of Supervisors Resolution 93-1391; and
4. Approve Planning Application PA20-0255 for the certification of the subject applicants for inclusion in the County’s list of “Certified Acoustical Consultants” for a period of five (5) years, subject to the attached Findings and Conditions of Approval.
