



NOTICE OF PUBLIC HEARING

BY THE ORANGE COUNTY SUBDIVISION COMMITTEE

SUBJECT: "B" Vesting Tentative Tract Map 19025 within Planning Area 3, Subarea 3.1, Ranch Plan Planned Community

LOCATION: Subarea 3.1, Lots 1 through 11 and 74 of "A" Tract Map 17931 of the Ranch Plan Planned Community, in southeastern unincorporated Orange County, east of Ranch Canyon and north of Saddle Way, within the Fifth (5th) Supervisorial District.

PROPOSAL: Rancho Mission Viejo requests approval of "B" Vesting Tentative Tract Map 19025 (VTTM 19025) to subdivide a 8.16-acre site within Subarea 3.1 of the Ranch Plan Planned Community into 104 legal lots: 73 numbered lots for planned concept single-family detached dwellings, 8 numbered lots for pocket parks and landscaping, 1 lettered lot for a public street, 12 lettered lots for private streets and alleys, and 10 lettered lots for landscaped open space areas.

ENVIRONMENTAL DOCUMENTATION: The proposed project is covered by previous CEQA documentation, which includes Final Program EIR 589, which was certified on November 8, 2004; Addendum 1.0, approved on July 26, 2006; Addendum 1.1, approved on February 24, 2011; the Planning Area 2 Addendum, approved on March 27, 2013; and Addendum 3.1, approved February 25, 2015. This finding is appropriate and complies with the intent of CEQA, pursuant to the Orange County 2020 Local CEQA Procedures Manual, Section 13.1 for projects where a previous environmental document (i.e. Program EIR 589) is already in place. Further CEQA evaluation and clearances are not required for proposed "B" VTTM 19025.

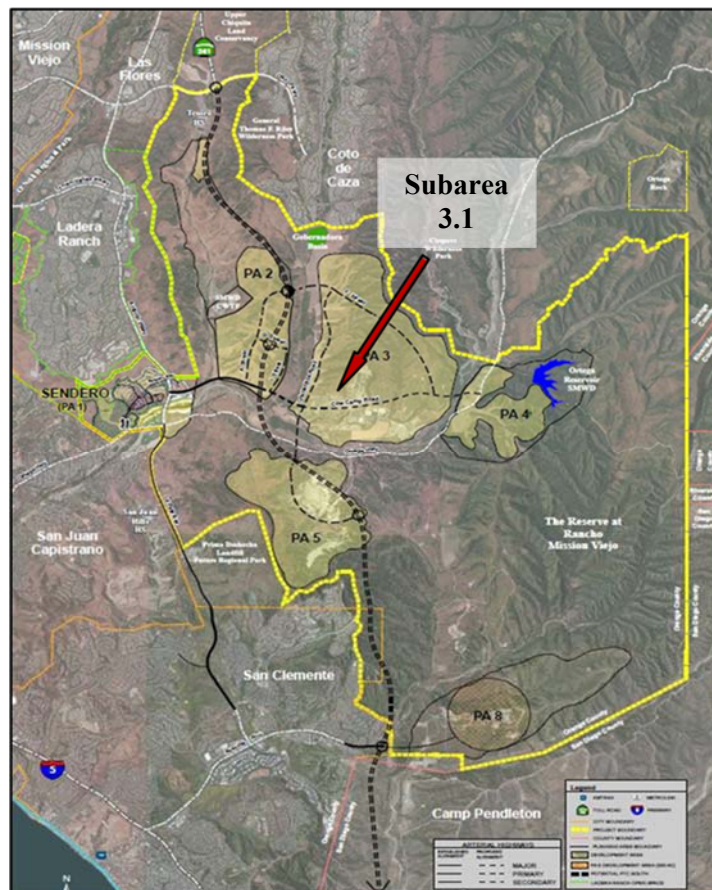

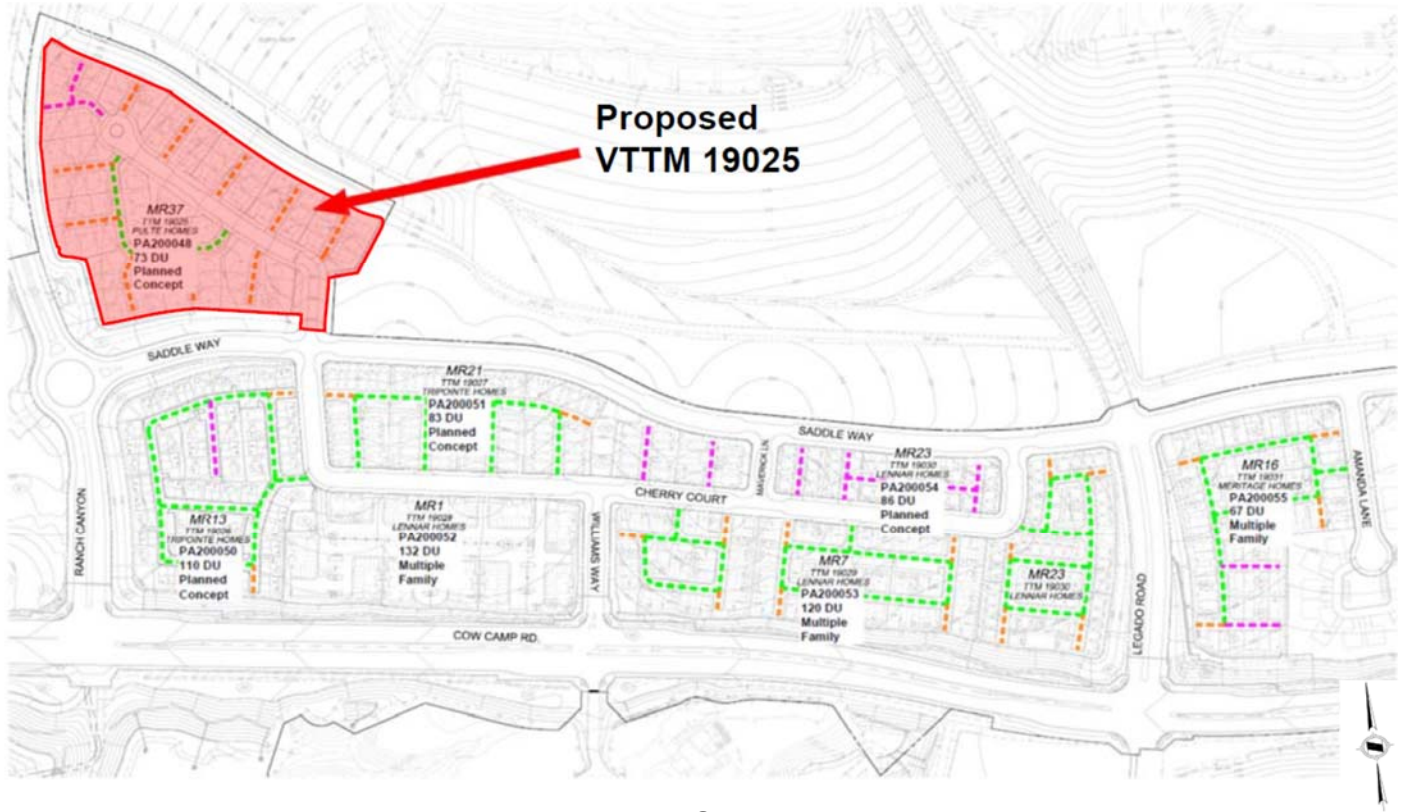
