

NOTICE OF PUBLIC HEARING

BY THE ORANGE COUNTY BOARD OF SUPERVISORS

SUBJECT: DENIAL OF APPEAL BY THE FOOTHILL COMMUNITIES ASSOCIATION AND APPROVAL OF PLANNING APPLICATION PA21-0055 (CHABAD OF TUSTIN) FOR A USE PERMIT, VARIANCE AND SHARED PARKING AGREEMENT AND FINDING THAT NEGATIVE DECLARATION NO. PA21-0055 REFLECTS THE INDEPENDENT JUDGMENT OF THE COUNTY OF ORANGE AS LEAD AGENCY AND SATISFIES THE REQUIREMENTS OF THE CALIFORNIA ENVIRONMENTAL QUALITY ACT FOR THE CHABAD OF TUSTIN PROJECT (PA21-0055).

PROPOSAL: The Chabad of Tustin project proposes the development a 9,850 square foot place of worship, the Chabad of Tustin, with a 50 fixed-seat sanctuary and other accessory spaces, including a social area and kitchen/pantry, Torah library, administrative offices, two classrooms and a lobby area. Portions of the outdoor areas would be developed as passive areas for fellowship and social gatherings. An accessory use is also proposed for the operation a State-licensed private preschool with a play yard.

LOCATION: The property is located on 18802 East 17th Street in the unincorporated North Tustin area, within the Third (3rd) Supervisorial District. (APN 401-081-12.)

APPLICANT: Chabad of Tustin Inc.

PREVIOUS ACTIONS: On March 9, 2022, the Planning Commission considered the subject project during a publicly noticed hearing and received the staff report and public testimony from the applicants and interested members of the public. Following the public testimony, the Commission discussed the project and then voted unanimously to approve the project and Negative Declaration subject to presented findings and conditions of approval.

ENVIRONMENTAL DOCUMENTATION: Negative Declaration No. PA21-0055 has been recommended for approval for the project.
