In compliance with section 15072 of the California Environmental Quality Act (CEQA) Guidelines and the County of Orange Procedures, notice is hereby given to State Responsible and Trustee agencies, interested groups, and the public that the County of Orange shall adopt Proposed Mitigated Negative Declaration (MND), County File Number PA 21-0111 for the Fairlynn Townhomes Project.


