Findings  
PA23-0132**

- 
- 1** **GENERAL PLAN** **PA23-0132**  
 That the use or project proposed is consistent with the objectives, policies, and general land uses and programs specified in the General Plan adopted pursuant to the State Planning and Zoning Law.
- 
- 2** **ZONING** **PA23-0132**  
 That the use, activity or improvement(s) proposed, subject to the specified conditions, is consistent with the provisions of the Zoning Code, or specific plan regulations applicable to the property.
- 
- 3** **COMPATIBILITY** **PA23-0132**  
 That the location, size, design and operating characteristics of the proposed use will not create unusual conditions or situations that may be incompatible with other permitted uses in the vicinity.
- 
- 4** **GENERAL WELFARE** **PA23-0132**  
 That the application will not result in conditions or circumstances contrary to the public health and safety and the general welfare.
- 
- 5** **PUBLIC FACILITIES** **PA23-0132**  
 That the approval of the permit application is in compliance with Codified Ordinance Section 7-9-711 regarding public facilities (fire station, library, sheriff, etc.).
- 
- 6** **CATEGORICALLY EXEMPT** **PA23-0132 CUSTOM**  
 That the proposed project is Categorically Exempt from the California Environmental Quality Act (CEQA) under the Class 2 exemption pursuant to Section 15302 of the California Environmental Quality Act (CEQA) Guidelines and County of Orange procedures, as discussed in detail within the project Staff Report. The project will not result in a cumulative impact, significant environmental effect or damage scenic or historic resources. Standard conditions of approval applied by the County for all construction projects of this nature will address any short-term construction related impacts.

- 7** **FISH & GAME - EXEMPT** **PA23-0132**  
 That pursuant to Section 711.4 of the California Fish and Game Code, this project is exempt from the required fees as it has been determined that no adverse impacts to wildlife resources will result from the project.

- 8** **NCCP NOT SIGNIFICANT** **PA23-0132**  
 That the proposed project will not have a significant unmitigated impact upon Coastal Sage Scrub habitat and therefore, will not preclude the ability to prepare an effective subregional Natural Communities Conservation Planning (NCCP) Program.

**9** **COASTAL DEVELOPMENT PERMIT 1** **PA23-0132**  
 That the development project proposed by the application conforms to the certified Local Coastal Program.

**10** **COASTAL DEVELOPMENT PERMIT 2** **PA23-0132**  
 That the project conforms to the public access and public recreation policies of the California Coastal Act.

**11** **COASTAL DEVELOPMENT PERMIT 3** **PA23-0132**  
 That the approval of this application will result in no modification to the requirements of the certified land use plan.

---

**12** **COASTAL DEVELOPMENT PERMIT 4** **PA23-0132**  
 That the approval of the application will result in a project which is in full compliance with the requirements of the certified land use plan.

**13** **COASTAL DEVELOPMENT PERMIT  
 APPEAL AREA** **PA23-0132**  
 That the project is within the appealable area of the Emerald Bay Local Coastal Program.
