- 4. OC Development Services and Service Delivery Status Justin Kirk
 - Justin Kirk provided the following updates.
 - o APA California 2023 Legislative Update provided by Justin Kirk
 - Review of the most recent 2023 Legislative Update
 - The bills are primarily focused on land use, planning, housing, and environmental regulations
 - Due to the number of bills, there will be a second update that will focus on building and fire related issues
 - APA identified what is influencing the legislature:
 - a. Housing & Homelessness
 - b. Accountability & Implementation
 - c. Climate & Infrastructure
 - Approximately a \$30 billion-dollar budgetary deficit. The deficit led to the shifting of budgeting and fundings of certain programs.
 Looked to the federal government to backfill some of that.
 - OPR is going through a general plan guideline update which will affect most general plans in the state. This will come out in the next 2-3 years. Should be in place by 2026 within the 7th Cycle Housing Element Update.
 - Focused on the streamlining of CEQA, specifically for small scale housing (10 units or less) to get to a place where you can offer more categorical exemptions

Staffing update:

- Hired two additional staff members in Dev. Services. One in permitting and one with Planning.
- Continuing to hire and down to 14 vacancies. Down last year from 30 vacancies.
- Takes about 3 months to hire a staff member.

- Voting of the new chair for 2024 will be elected at that meeting.
- 2024 DPRC Meeting dates approved.
