

NOTICE OF PUBLIC HEARING

BY THE ORANGE COUNTY SUBDIVISION COMMITTEE

SUBJECT: "A" Vesting Tentative Tract Map 17935 for Planning Area 3, Subarea 3.5, The Ranch Plan Planned

Community

LOCATION: The project site is located north of Cow Camp Road, east of Gobernadora Canyon, in southeastern

unincorporated Orange County, in the 5th Supervisorial District.

PROPOSAL: Rancho Mission Viejo requests approval of "A" Vesting Tentative Tract Map 17935 (VTTM 17935) to

subdivide 176.77 acres into 151 total lots: 77 numbered lots for residential development, private parks, a recreation area, a future cellular tower site, future storm water management areas, landscape lots and monument signage; 74 lettered lots for vehicular access, open space/slopes, natural open space, and landscape lots. The map comprises the area identified as Subarea 3.5 in Planning Area 3 of the Ranch

Plan Planned Community.

ENVIRONMENTAL DOCUMENTATION: The proposed project is covered by previous CEQA documentation, which includes Final Program EIR 589, which was certified on November 8, 2004; Addendum 1.0, approved on July 26, 2006; Addendum 1.1, approved on February 24, 2011; the Planning Area 2 Addendum, approved on March 27, 2013; and Addendum 3.1 approved on February 25, 2015. This finding is appropriate and complies with the intent of CEQA pursuant to the 2020 Orange County Local CEQA Procedures Manual, Section 13.1 for projects where a previous environmental document (i.e. Program EIR 589) is already in place. Further CEQA evaluation and clearances are not required for proposed "A" VTTM 17935.


INVITATION TO BE HEARD:


