    - Housing Element
      - Going to the Board on December 17, 2024 for adoption.

      - Will reevaluate group home ordinances due to changes in state law requiring less permitting.
    - Adoption of RHNA transfer policy.
      - As unincorporated communities would incorporate, the RHNA obligations were not transferred to them from the County. The County retained a significant amount of obligation while as unincorporate areas dwindled.
      - The new policy calculates RHNA obligations by based upon the total area of the incorporated area.
