#### I. CONSENT ITEMS

ITEM #1. MINUTES OF APRIL 23, 2025

## II. DISCUSSION ITEMS

ITEM#1. PUBLIC HEARING – GENERAL PLAN AMENDMENT \$19-01 (SAFETY ELEMENT), APPLICANT – OC DEVELOPMENT SERVICES – UNINCORPORATED AREAS OF ORANGE COUNTY – ALL SUPERVISORIAL DISTRICTS.

Consider for Board of Supervisors recommendation, an amendment to the County's Safety Element to incorporate policies intended to comply with recent State mandated changes regarding fire safety and to make additional technical amendments.

#### **RECOMMENDED ACTION(S):**

OC Development Services/Planning recommends the Planning Commission:

- a. Receive staff report.
- b. Conduct public hearing.
- c. Adopt Planning Commission Resolution No. 2025-04, recommending that the Board of Supervisors:
  - 1. Find that Initial Study/Negative Declaration (IS/ND) No. IP 22-0133, previously adopted by the Board of Supervisors on September 27, 2022, and Addendum No. 1 adopted by the Board of Supervisors on June 25, 2024, for the Housing-Related Updates to the County of Orange General Plan and Comprehensive Zoning Code, adequately address the effects of the proposed project, reflect the independent judgement of the County of Orange, and are approved for the proposed project based on the additional findings that the circumstances of the project are substantially the same, and IS/ND No. IP 22-0133 and Addendum No. 1 adequately address the effects of the proposed project; no substantial changes have occurred in the circumstances under which the project is being undertaken; and no new information of substantial importance to the project which was not known or could not have been known when the IS/ND No. IP 22-0133 and Addendum No. 1 were adopted has become known; therefore no further environmental review is required.
    - a. IS/ND No. IP 22-0133 and Addendum No. 1 are adequate to satisfy the requirements of CEQA for General Plan Amendment S19-01.
  - 2. Adopt General Plan Amendment S19-01 to the Orange County Safety Element for compliance with recent State mandated changes regarding fire safety and to make additional technical amendments.

# ITEM #2 SECOND STUDY SESSION FOR GENERAL PLAN AMENDMENT GPA 24-03 AND ZONING CODE AMENDMENT CA 24-03 – BATTERY ENERGY STORAGE SYSTEM ORDINANCE, APPLICANT – OC DEVELOPMENT SERVICES, LOCATION – UNINCORPORATED AREAS OF ORANGE COUNTY, ALL SUPERVISORIAL DISTRICTS

Staff will provide information in response to Planning Commission feedback from the first study session and present the proposed draft zoning code amendment text relating to Battery Energy Storage System (BESS) facilities. The proposed ordinance will only apply to BESS facilities located within unincorporated areas of the County of Orange.

- Eric Wygan from San Diego Gas & Electric is in favor of the BESS facilities but has concerns about the 500ft setback currently listed in the staff report. - Kelly Lee from So-Cal Edison has requested a little more time for their staff to review. Shares Eric Wygans concerns. Also, appreciative that County staff has solicited SCE's feedback.
