**Dear OC board Zoning commission**

**This is Donovan & Kathleen Aakhus at [REDACTED], one of the four closest houses (within 100 feet) to the planned two 40 foot cel towers.**

**We strongly oppose this cel tower location as it is so close to our home (100'), and is directly overhead of a children's park. We agree with our neighbors**

**that it is a huge fire hazard, it's too close to homes and a children's park, has a negative effect on property values, visual appeal and environmental concerns.**

**We feel there are other and less damaging areas further up the golf course or other areas that these towers could be placed.**

**We know the US Government says health and human safety factors don't apply to cel tower locations and that is not entirely true!**

**Let me tell you about always BELIEVING the U S Government;**

**I am a USAF Vietnam Veteran Combat Pilot who served your country from 1967 to 1973. I am a 100% medically disabled veteran for prostate cancer from Agent Orange for serving in Vietnam, as now determined by your United States Government.
