



NOTICE OF PUBLIC HEARING

BY THE ORANGE COUNTY BOARD OF SUPERVISORS

SUBJECT: Zoning Code Amendment CA 25-02 (County of Orange commercial cannabis activities and outdoor personal cultivation prohibition ordinance) an Ordinance of the County of Orange, State of California, amending sections 3-14-2 through 3-14-16, 5-1-31, 5-1-33 and 7-9-103 of the Codified Ordinances of the County of Orange.

PROPOSAL: Recommend for adoption by the Board of Supervisors the proposed Zoning Code Amendment CA 25-02 to Orange County Comprehensive Zoning Code section 7-9-103, County of Orange commercial cannabis activities and outdoor personal cultivation prohibition ordinance and sections 3-14-2 through 3-14-16 (Abatement Warrants and Summary Abatement), 5-1-31 (Sale, distribution, commercial cultivation, delivery, manufacturing, and testing of cannabis or any other controlled substances), and 5-1-33 (Civil fine; businesses selling or distributing cannabis or any other controlled substances).

PROJECT LOCATION: Unincorporated Areas of the County of Orange

APPLICANT: OC Public Works/OC Development Services

PREVIOUS ACTIONS: On December 10, 2025, the Orange County Planning Commission held a public meeting regarding the proposed Zoning Code Amendment CA 25-02 and voted to recommend the Board of Supervisors make the appropriate findings under the California Environmental Quality Act (CEQA) and adopt Zoning Code Amendment 25-02.

ENVIRONMENTAL DOCUMENTATION: This action is not a project within the meaning of the California Environmental Quality Act Guidelines Section 15378 and is therefore not subject to CEQA, since it does not have the potential for resulting in either a direct physical change in the environment, or a reasonably foreseeable indirect physical change in the environment. The approval of this agenda item does not commit the County to a definite course of action in regard to a project, since it is an update to the County of Orange Nuisance Abatement Ordinances. This proposed activity is, therefore, not subject to CEQA. Any future action connected to this approval that constitutes a project will be reviewed for compliance with CEQA.
