## II. <u>DISCUSSION ITEM(S)</u>

ITEM #1 PUBLIC HEARING – ZONING CODE AMENDMENT CA 19-01 – COMMUNITY CARE FACILITY AND GROUP HOME REGULATIONS, APPLICANT – COUNTY OF ORANGE – LOCATION – UNINCORPORATED AREAS OF ORANGE COUNTY – ALL SUPERVISORIAL DISTRICTS.

Adoption of Zoning Code Amendment CA 19-01 by the Board of Supervisors will revise existing portions of, and add new sections to, the Codified Ordinances of the County of Orange regarding community care facilities and group homes.

- a) Receive staff report and public testimony as appropriate.
- b) Adopt Planning Commission Resolution No. 19-02 (Attachment 1), which will:
  - 1. Find that Zoning Code Amendment CA 19-01 is exempt from the provisions of CEQA pursuant to Section 15061(b)(3) of the CEQA Guidelines.
  - 2. Recommend the Board of Supervisors
    - a. Find that Zoning Code Amendment CA 19-01 is exempt from the provisions of CEQA pursuit to Section 1506(b)(3) of the CEQA Guidelines.
    - b. Adopt proposed Zoning Code Amendment CA 19-01 regarding Community Care Facility and Group Home Regulations.
