SUBJECT: General Plan Amendment T19-02 – Transportation Element

PROPOSAL: Amend the County of Orange Circulation Plan, contained in the General Plan

Transportation Element, to remove from the Circulation Plan: (1) a portion of Graham Street (a conceptually proposed roadway), and (2) a portion of Talbert Street from the City of Huntington Beach (City) limits to its current terminus on the MPAH (a conceptually proposed roadway). These amendments are proposed to conform the Circulation Plan to the Orange County Master Plan of Arterial Highways (MPAH),

administered by the Orange County Transportation Authority (OCTA).

RECOMMENDED ACTION(S):

OC Development Services/Planning recommends the Planning Commission:

- a. Receive staff report and public testimony.
- b. Adopt Planning Commission Resolution No. 19-05 (Attachment 1) recommending that the Board of Supervisors make the appropriate findings under the California Environmental Quality Act (CEQA) and adopt proposed General Plan Amendment T 19-02 Transportation Element that will update the County of Orange Circulation Plan (Attachment 2).

BACKGROUND:

Staff received authorization from the Planning Commission on October 22, 2019 to initiate the General Plan Amendment T 19-02 – Transportation Element to update the County of Orange Circulation Plan. Planning staff coordinated with OC Public Works/Survey to update the Circulation Plan to incorporate the proposed revisions (Attachment 2)

The County of Orange Transportation Element contains the County's policies on the development of the transportation facilities necessary to accommodate the orderly growth of the County. The Transportation Element identifies goals, objectives, policies, and implementation programs that affect the transportation system and provide guidance for future planning efforts within the unincorporated area. The Transportation Element contains the Circulation Plan, Bikeways Plan, and Scenic Highways Plan. The proposed changes do not involve the Scenic Highway Plan. Implementation of these three plans is necessary to ensure a balanced transportation system.

A goal identified in the Transportation Element is to "provide a Circulation Plan that is integrated with that of adjacent jurisdictions." To achieve this goal, the County's transportation system is designed to be compatible with adjacent jurisdictions and amended as necessary to remain consistent with the Orange County Master Plan of Arterial Highways (MPAH), administered by the Orange County Transportation Authority (OCTA). The MPAH depicts a Countywide roadway network intended to ensure coordinated transportation system development among local jurisdictions in Orange County. The MPAH describes an arterial highway system that effectively serves existing and adopted future land uses in both incorporated and unincorporated areas of the County.

OCTA responsible for maintaining its integrity and Countywide consistency. OCTA reviews the circulation plans of all local OC jurisdictions for consistency every two years, and works with any jurisdictions that need to make necessary amendment to bring their plan into compliance. Consistency with the MPAH is essential to the integrity of a functional regional highway network so jurisdictions are aware of the existing conditions, and able to adequately plan for various changes.

PROPOSED PROJECT:

In the OCTA MPAH, there are six (6) classifications of arterial highways: Principal (8 lane divided roadway), Major (6 lane divided roadway), Primary (4 lane divided roadway), Secondary (4 lane undivided roadway), Divided Collector (2 lane divided roadway), and Collector (2 lane undivided roadway).

Due to previous MPAH amendments within the Bolsa Chica Wetlands area, Graham Street and Talbert Avenue are not currently connected to other roadways and are not planned to connect with other regionally significant roadways on the Circulation Plan because these linkages no longer serve a regional purpose. Therefore, for the

reasons indicated above, OCPW/Infrastructure Programs proposes to remove the highway designations of these roadways in the County's Circulation Plan for the unbuilt portions of those roadways.

Proposed General Plan Amendment T19-02 includes the following revisions to the Circulation Plan:

1. Remove Graham Street from the Circulation Plan from the City limits to its current terminus on the MPAH, currently classified as a Secondary (four-lane, undivided) Arterial.

The County's Circulation Plan currently classifies Graham Street (a conceptually proposed roadway), from the City of Huntington Beach (City) limits to its current terminus on the MPAH, as a Secondary Arterial. The proposed amendment to the Circulation Plan will remove the roadway.

2. Remove Talbert Avenue from the City limits to its current terminus on the MPAH, currently classified as a Primary (four-lane, divided) Arterial.

The County's Circulation Plan currently depicts Talbert Avenue (a conceptually proposed roadway), from the City limits to its current terminus on the MPAH, as a Primary Arterial. This proposed update to the Circulation Plan will remove this roadway.

Pursuant to the OCTA Board's conditional approval action on March 10, 2014 (Attachment 3), the approval to (1) remove Graham Street and (2) remove Talbert Avenue from the City limits to its current terminus on the MPAH remains conditional until OCTA receives documentation that the County of Orange has amended their general plan and complies with the requirements of the California Environmental Quality Act.

The City of Huntington Beach (City) provided an Amendment Request letter to OCTA on January 23, 2014 to delete Graham Street and Talbert Avenue from the MPAH (Attachment 4). Since then, the City has amended their General Plan on October 2, 2017 to remove the City's portion of Talbert Avenue and Graham Street. Upon the County's adoption of the proposed amendment, OCTA will approve the amendment to the MPAH.

CEQA COMPLIANCE:

The proposed project is Categorically Exempt (Class 15061(b)(3) and 15262) from the provisions of CEQA pursuant to Section 15061(b)(3) and 15262, since these amendments respectively fall within CEQA's common sense exemption, and statutory exemption for planning and feasibility studies.






ATTACHMENT 2 CIRCULATION PLAN

County of Orange, California





6 Lane Divided Roadway


Accommodates 30,000 to 45,000 ADT

On March 10, 2014 the Orange County Transportation Authority (OCTA) Board of Directors (Board) approved an amendment to the Master Plan of Arterial Highways (MPAH). The amendment approved the following changes within the County of Orange (County):

- Removal of Graham Street from the Huntington Beach city limits to its current terminus on the MPAH; and
- Removal of Talbert Avenue from the Huntington Beach city limits to its current terminus on the MPAH.

The Board's approval remains conditional, until OCTA has received:

Documentation that the County of Orange and the City of Huntington Beach (City)
have amended their respective general plans and have complied with the
requirements of the California Environmental Quality Act.

Once these actions have occurred, please provide OCTA with copies of appropriate supporting documentation. Upon receipt of documentation from the County and the City, the MPAH will be updated accordingly.

Subject: Request for MPAH Amendment

Dear Mr. Alcock:

The City of Huntington Beach requests that OCTA consider three amendments to the Master Plan of Arterial Highways in support of implementing the City's Circulation Element of the General Plan. Back in February 2013, the City approved an update to our Circulation Element that identified several street sections that had been either been over-classified or are no longer needed for regional traffic needs. Many of the street sections were addressed in a prior action by OCTA, but we continue to pursue completion of amendments to several remaining segments. The three amendments outlined in this letter appear to be very minor in nature based on the current transportation landscape of the area. The Graham Street and Talbert Avenue amendments directly tie into segments within the Bolsa Chica Wetlands area of the County of Orange. It is our understanding that the County of Orange has provided formal support for these amendments to OCTA.

The City of Huntington Beach request consideration of the following MPAH amendments:

- 1. Graham Street MPAH Deletion: Huntington Beach is requesting that the segment of Graham Street south of Slater Avenue be deleted from the MPAH. This segment of Graham is no longer needed to meet any regional mobility needs and does not need to be retained as a Secondary Arterial. With the elimination of the Cross Gap Connector through the Bolsa Chica Wetlands area several years ago by OCTA, the roadway is not expected to ever connect with any other regionally significant roadways. Traffic volumes projections for this segment of Graham are expected to remain at current levels of 3,000 vehicles per day.
- 2. <u>Talbert Avenue MPAH Deletion</u>: Huntington Beach is requesting that the segment of Talbert Avenue west of Springdale Street be deleted from the MPAH. This segment of Talbert no longer is needed to meet any regional mobility needs. With the elimination of the Cross Gap Connector through the Bolsa Chica Wetlands area several years ago by OCTA, the roadway is not expected to ever connect with any other regionally significant roadways and is not needed as a

- Primary Arterial. Traffic volumes projections for this segment of Talbert are expected to remain at current levels of less than 3,000 vehicles per day.
- 3. 6th Street MPAH Classification Downgrade: Huntington Beach is requesting that the section of 6th Street between Main Street and Lake Street be reclassified to a Collector Arterial, consistent with the portion of 6th Street from PCH to Main Street. This section was inadvertently omitted from the reclassification request for the rest of 6th Street. The 2030 traffic projections for this segment are approximately 5,000 vehicles per day, well below the maximum service volumes of 10,000 vehicles per day for a Collector.

In the approval actions of the Circulation Element, the City Council authorized final action of these amendments pending approval by OCTA. Detailed information was provided following completion of our last set of amendments. If needed, we can formally resubmit this information when needed.

Associated with the requested amendments for Talbert and Graham, the City of Huntington Beach also supports the requested deletion of these segments and the connecting roadway within the Bolsa Chica Wetlands area by the County of Orange. We believe these changes will not affect regional mobility and access and would be consistent with the requested actions by the City of Huntington Beach.
